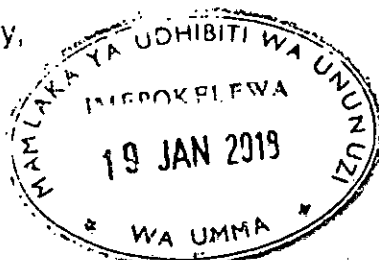

The Authority intends to apply part of the funds to cover eligible payments under the contract for Supply of Headsets, Handsets and Walkie Talkies for Tanzania Civil Aviation Authority
3. Tanzania Civil Aviation Authority now invites sealed tenders from eligible Suppliers for Supply of Headsets, handsets and Walkie Talkies.
